

NOTICE IS HEREBY GIVEN that the Land Court shall conduct Hearings to determine the ownership of certain parcels of land located **Meriiil, Pulo Ana and Dongosaro** of **Sonsorol State**, which are more particularly described in detail on the attachment calendar with claimants and hearing set for:

Date/Time : **April 22 - May 14, 2002 - 9:00 am**

Place : **Land Court Courtroom A, Koror State**

Mandatory Monumentation and Mediation Session (35 PNCA §1307 and amendments thereto in RPPL No. 5-22).

Prior to the hearings, claimants or their representatives will clear and monument boundaries of their claim(s) during the monumentation. The *Sonsorol State Land Registration Officer* will assist claimants or their representative during the *Monumentations set as follows:*

Date & Time: **March 6, 2002, 8:30 am - Meriiil & Pulo Ana**

March 18, 2002, 8:30 am - Dongosaro

Place : **State Office, Sonsorol State**

A Mediation Session to assist claimants in resolving their boundary disputes is required by RPPL No. 5-22 and in resolving their disputes as required by Rule 13 of the rules and regulations of the Land Court. Disputing claimants must select a mediator from the list of certified mediators provided by the Land Court. **Mediation Session shall take place on the date, time and place set by the selected mediator and the claimants.**

Penalty for failure to attend Monumentation (35 PNCA § 1307(c))

All claimants or their representatives are required to be present at the monumentation and mediation session. Any claimant who fails to personally attend or send an authorized representative shall pay a penalty of \$250.00 to the Clerk of Courts within 10 days of the scheduled monumentation. A claimant who fails to attend a scheduled monumentation for a second time may not contest the boundary determinations and monumentations resulting from the session.

Procedure and Deadline for filing Claims (35 PNCA § 1308 (a))

All persons or group of persons who has interest in or claim to the land(s) described herein but has not file a claim must file a written claim with the Land Court no later than 60 days prior to the hearing in this notice. *Deadline date for Filing Claim: **See attached calendar***

Claim forms may be obtained from the main offices of the Land Court located in Madalaih, Koror State, whose telephone numbers are listed above; or from any Land Court Registration Officer of each State. Registration Officers or other Land Court staff will provide assistance in preparing written claims without charge.

Forfeiture of Claims

A claimant who fails to timely file his or her claim by the deadline date forfeits that claim.

Nature of the Hearing Proceedings and Land Court Rules of Procedures


The Hearing will be conducted in Palauan unless the Land Court orders otherwise. Claimants may present their claims with or without assistance of counsel, but must comply with the Land Court Rules of Procedure. The Rules of Procedure govern Hearings before the Land Court and are available at the Offices of the Land Court and the Supreme Court Library.


